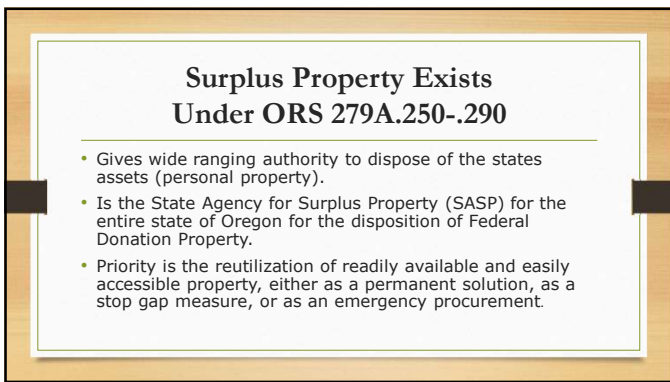

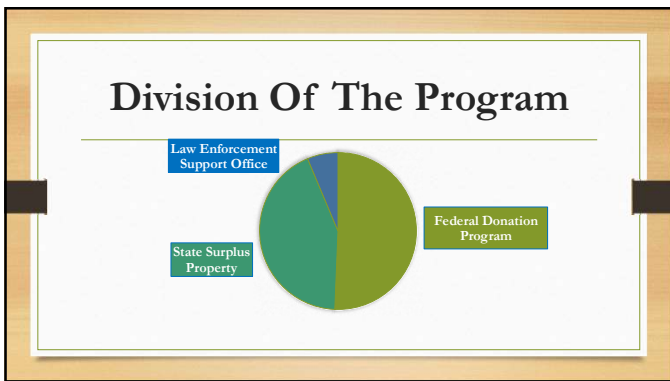

## The Eligibility Process

1. Complete The Application
2. Assign Authorized Signers
3. Who Decides What?  
President, Chairman of the Board, County Judge, Mayor, City Manager, Executive Director, Administrator, Fire Chief, Comparable Authorized Official
4. What Do You Agree To When Getting Federal Donation Property?  
When you get it, you will put it into use within 1 year. Then, you need to keep it for:
  - 12 Month Compliance- For property with a unit acquisition value of less than \$5,000
  - 18 Month Compliance- For passenger motor vehicles or any item of property having a unit acquisition value of \$5,000 or more
  - 60 Month Compliance- For aircraft and vessels 50 feet or more in length
  - In Perpetuity- For combat-configured aircraft, and firearms

### What Do You Agree To When Acquiring Federal Donation Property?

- You will use the property only in the official program you represent. Personal use or non-use is not allowed.
- You will use items during their respective compliance period
- You will not sell, loan, trade or cannibalize the acquired property during the compliance period, unless we give you written permission to do so
- You will pay the Federal Government if you do not use the property according to your agreement
- The property you acquire will be considered Federal Financial Aid (23.4% of the price the Federal Government originally paid for the item).

### Bottom Line.....How Do We Get Stuff?

- Search online at [www.oregonsurplus.com](http://www.oregonsurplus.com), visit the Salem warehouse, or call our agency salesperson at 971-301-0193.
- Pick out what you want or need
- Not an authorized signer? We can put it on hold for 5 days
- We will generate an invoice. We need an authorized signature before it leaves
- We will bill you, or you can pay by agency credit card
- Put it into use within one year and keep it for your compliance period. After that, you can keep it or sell it.
- If you need something, and we don't have it, submit a "Want List" request, and we'll keep an eye out for it (no obligations).
- We can ship items directly from the item's location (from federal installation where it is located, or from the Salem Warehouse).

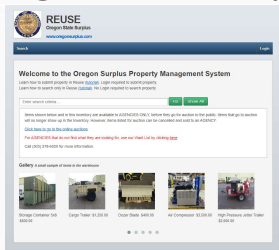

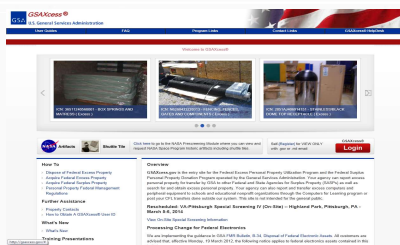

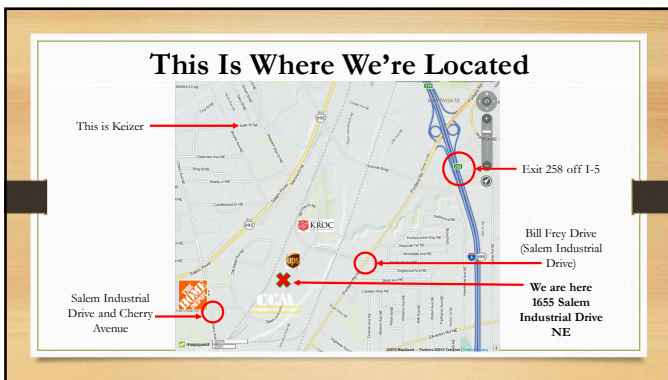
