Stay In"Formed"

The E-1 Form serves a similar function for new personnel as the Personnel Agency Form (PAF), but it allows Fire Service Agencies to go one step further by affiliating new personnel as well as allow the new affiliate to submit their fingerprints at the same time without waiting to submit an application for certification. This form is meant to be used for only new personnel who have not already been fingerprinted but will require DPSST certification. It is also the only way to submit fingerprints to DPSST for processing without an attached application for certification. Below you will find some tips about the proper way to fill out an E-1 form to help make the process as smooth as possible.
