Professional Standards—Private Security

To increase the public's trust, the Oregon legislature has mandated the Board on Public Safety Standards and Training establish minimum standards for all private security providers in the state. The minimum standards for this program are defined in Oregon Administrative Rule Chapter 259, Division 60. The Department of Public Safety Standards and Training (Department) is responsible for certifying and licensing private security professionals, instructors and managers who meet all of the Board-established standards, and for denying or revoking the certification or licensure of those who do not meet or fall below the standards.

The Professional Standards Ethics Bulletin has been developed as an educational tool aimed at providing insight and transparency into situations involving applicants for certification or licensure and current providers who may have violated the minimum standards. This publication is meant to provide insight into the types of behaviors that resulted in revocation, denial, suspension or civil penalty of private security certification and licensure over the last two months. The bulletin details the conduct and the resulting Department action. The names of the individuals in this bulletin have been omitted to ensure focus remains on the behavior. This is a sampling of cases and not meant to describe all past actions taken by the Department over the last two months.

THE FOLLOWING CASES HAVE RESULTED IN **DENIAL** OF CERTIFICATIONS AND LICENSES BY DPSST **MAY 2021 THROUGH JUNE 2021**

ALL APPLICANTS WERE SERVED WITH A NOTICE OF PROPOSED DENIAL BASED ON DISCRETIONARY AND/OR DISQUALIFYING CONDUCT PRIOR TO CERTIFICATION AND GIVEN AN OPPORTUNITY TO SUBMIT MITIGATING INFORMATION

- APPLICANTS 1–3 FAILED TO RESPOND TO THE NOTICE AND THEY WERE DISQUALIFIED/DENIED.
- APPLICANTS 4-5 WITHDREW THEIR APPLICATION AND THE CASE WAS ADMINISTRATIVELY CLOSED.

Applicant 1, an Unarmed Professional, engaged in discretionary disqualifying misconduct (dishonesty or deceit). The individual was convicted of Obtaining Money or Goods by Fraud and Credit Card Fraud in another jurisdiction. (Disqualifying conduct is based on dishonesty or deceit, sexual misconduct, drug related misconduct, destruction of property, or violence, abuse or neglect against a person or animal where the conduct occurred within the four years prior to certification or while certified).

Applicant 2, an Unarmed Professional, was convicted of Felony Driving Under the Influence of Intoxicants. Under the 2020 Oregon Administrative Rule (OAR), this is a lifetime disqualifier for certification. The applicant submitted his application to the Department in 2020.

Applicant 3, an Unarmed Professional, was convicted of Luring a Minor, a Class C Felony, within the four years prior to certification. Less than four years had passed since completion of the court ordered requirements.

Applicant 4, an Unarmed Professional, engaged in discretionary disqualifying misconduct. The individual was terminated from his employment for consuming intoxicants while performing the duties of a private security provider and was also on diversion for Assault in another jurisdiction. Applicant had several other arrests within the past ten years prior to application. The application was submitted under the 2020 Oregon Administrative Rule (OAR) and pursuant to the 2020 OAR, the applicant violated moral fitness requirements by having three or more arrests within a ten year period, demonstrated lack of character and lack of public trust. Application was withdrawn.

Applicant 5, an Unarmed Professional, was convicted of Unlawful Possession of a Firearm within the four years prior to certification. The applicant falsified her application for certification and did not disclose that her conduct leading up to her conviction included theft of a firearm and having a concealed firearm at the time of her law enforcement contact. Application was withdrawn.

THE FOLLOWING CASES HAVE RESULTED IN **REVOCATION** OF CERTIFICATIONS AND LICENSES BY DPSST MAY 2021 THROUGH JUNE 2021

ALL PROVIDERS WERE SERVED WITH A NOTICE OF PROPOSED REVOCATION BASED ON DISCRETIONARY AND/OR DISQUALIFYING CONDUCT WHILE CERTIFIED AND GIVEN AN OPPORTUNITY TO SUBMIT MITIGATING INFORMATION.

- PROVIDER A RESPONSED TO THE NOTICE BY REQUESING A HEARING. THE PRO-VIDER DID NOT PREVAIL AT THE HEARING AND THEY WERE DISQUALIFIED/ REVOKED.
- PROVIDER B SURRENDERED THEIR CERTIFICATION AND THEIR CASE WAS ADMINISTRATIVELY CLOSED.

Provider A, an Unarmed Professional, engaged in discretionary disqualifying misconduct (dishonesty or deceit). The individual shoplifted from the store he was contracted to provide loss prevention services with after his shift was over. After review of evidence and witness testimony, a determination was made by an administrative law judge. The Department prevailed and revocation of the provider was upheld. (Disqualifying conduct is based on dishonesty or deceit, sexual misconduct, drug related misconduct, destruction of property, or violence, abuse or neglect against a person or animal where the conduct occurred within the four years prior to certification or while certified).

Provider B, an Unarmed Professional, engaged in discretionary disqualifying misconduct involving violence or abuse against a person while performing the duties of a private security professional. (Disqualifying conduct is based on dishonesty or deceit, sexual misconduct, drug related misconduct, destruction of property, or violence, abuse or neglect against a person or animal where the conduct occurred within the four years prior to certification or while certified). Provider surrendered certification.
