- Survey results are in, TRC is reviewing and compiling. In general, results indicated that we are on the right track with meeting intent of EO
- Working with ETO, focusing on Savings to Investment Ratio (SIR) vs. IRC to identify technical potential and achievable potential
- Assessment tool will be a GIS map (outcome/product). Use map to identify areas of opportunity.  
4 layers:
  - Energy burden by county, \$ gap to bridge energy burden
  - Breakdowns by fuel type, housing type, and vintage
  - Housing stock profile and distribution of affordable housing units in each county
  - Utility territories and energy assistance programs that exist
- On time to have draft of plan and tool by 10/22
- Request ODOE, PUC to come to Housing Stability Council to help present on 11/2
- OHCS needs residential rates by utility to feed into assessment. This data is available in the PUC stat book. ODOE to help gather data and confirm with PUC and send to OHCS.
