

EXHIBIT F PROPERTY OWNERSHIP

OAR 345-021-0010(1)(f)

INTRODUCTION

Archway Solar Energy LLC (Applicant) proposes to construct the Archway Solar Energy Facility (Facility) in Lake County, Oregon, with generating capacity of up to 400 megawatts (MW). The Facility may also contain a battery energy component with storage capacity of up to 400 MW and discharge capacity of up to 1,600 megawatt-hours. This Exhibit A presents applicant information as required by OAR 345-021-0010(1)(f).

OAR 345-021-0010(1)(f) *A list of the names and mailing addresses of property owners, as described in this subsection:*

(A) *The list must include all owners of record, as shown on the most recent property tax assessment roll, of property located:*

(i) *Within 100 feet of property which is the subject of the application, where the subject property is wholly or in part within an urban growth boundary;*

(ii) *Within 250 feet of the property which is the subject of the application, where the subject property is outside an urban growth boundary and not within a farm or forest zone; or*

(iii) *Within 500 feet of the property which is the subject of the application, where the property is within a farm or forest zone.*

(B) *The applicant must submit an updated list of property owners as required by the Department before the Department issues notice on any public hearing on the application for a site certificate as described in OAR 345-015-0220; and*

(C) *In addition to incorporating the list in the application, the applicant must submit the list to the Department in an electronic format approved by the Department.*

Response: A list of the names and mailing addresses of all owners of record, as shown on the most recent property tax assessment roll for Lake County, of property located within 500 feet of the property which is the subject of this application is included as Attachment F-1; these parcels are also shown on Figure F-1. Archway Solar Energy LLC will provide an updated list prior to public hearings as described in OAR 345-015-0220 and will provide these lists in an acceptable electronic format to the Department.

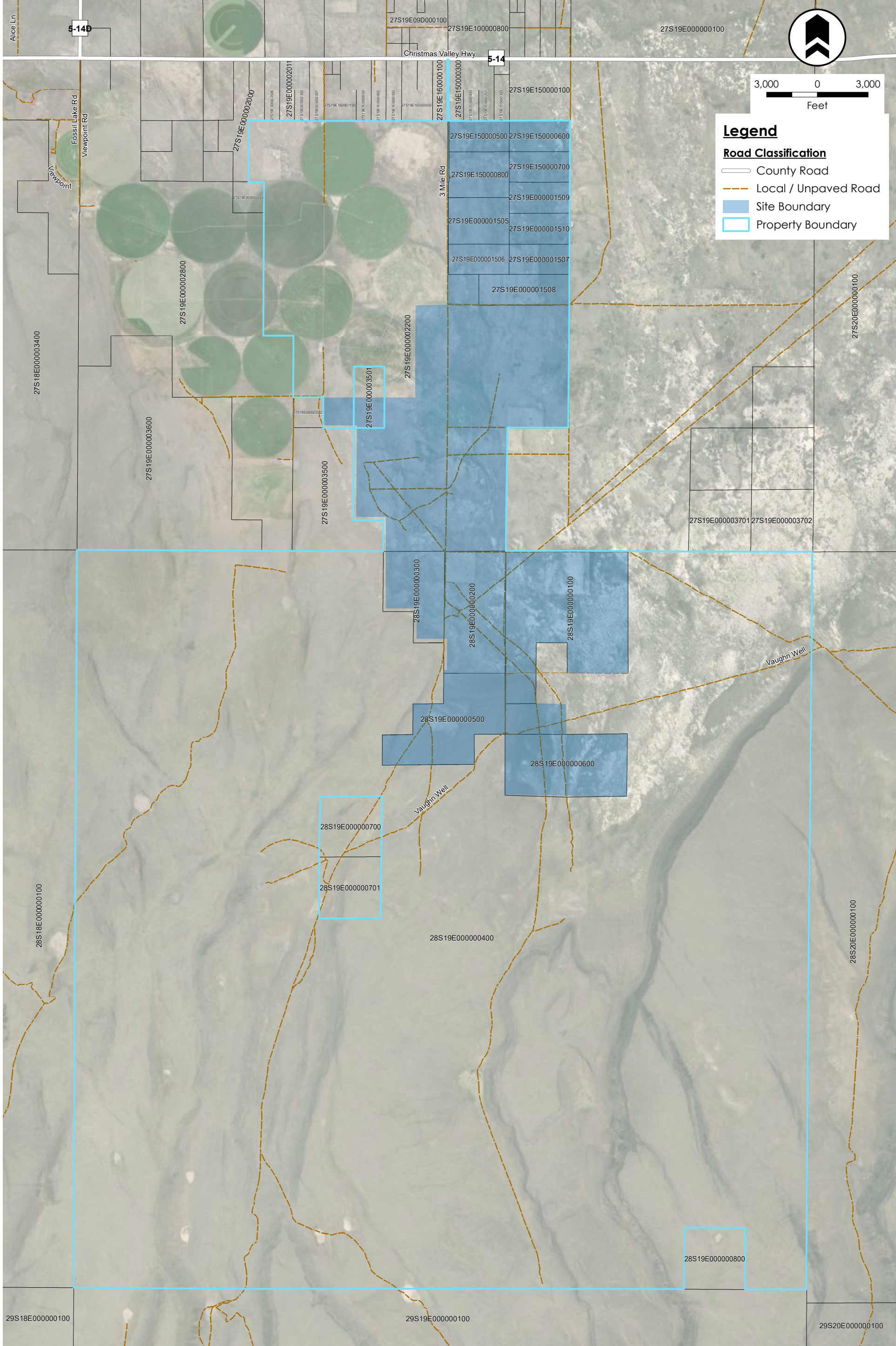


Figure F-1 - Property Map
