

- Pandemic creating uncertainty
- Fire season effects
 - Bootleg fire overlapped Sprague SIAs
- Extreme drought conditions

Staff are working to be aware of landowner challenges, adjust accordingly



Legislature/Budget Highlights

- Passed Ag Channel phased rollout (HB 2032)
- Maintained monitoring \$\$
- Maintained, even gained positions



Phased Ag Channel Rollout (HB 2032)



- Authorized regional rollout
- Will require rulemaking (specify regions, timing)
- Reconvene previous ACDM RAC
- Plan details TBD

DEQ TMDL Reporting (Total Maximum Daily Loads)



Why should I care?

- TMDL = DEQ tool for water quality (WQ) concerns
- ODA = WQ lead on ag lands (TMDL role w/DEQ)
- SWCD = Lead on WQ TA, education, outreach

SWCDs + ODA + TMDL implementation = Clean Water from Oregon's ag lands!

- Next step: Implementation plan (18 months)

Opportunity:

- NOTE: No change in rules

2013-2019:

- All 45 SWCDs; voluntary approach
- Challenges: Admin workload, COVID, new initiative (SIAs)
- Adaptive mgt: March SWCC, SWCD input

2021 - 2023:

- Now optional
- 17 SWCDs have 18 Focus Areas
- SWCDs developing measurable objectives
