Focusing on specific part of the Tualatin – Gales Creek sub-basin; removing barriers to provide access for native migratory fish for spawning and rearing. Partnering with Tualatin River Watershed Council, Clean Water Services, NRCS and additional ancillary partners; Oregon Dept of Fish and Wildlife, Oregon Dept. of Forestry, Confederated Tribes of the Grand Ronde.
