9:45 Presentation on Clean Rivers Coalition – Roy Iwai, Multnomah County

*The Clean Rivers Coalition is collaborative effort between municipal agencies, non-governmental organizations and other entities (e.g., SWCDs, state agencies) to build a bridge between clean water and healthy communities through education and engagement. In addition to holding multiple forums, the CRC has been working in partnership with a communications consultant to interview technical and outreach experts to determine the most impactful pollutants on our waterways and the most promising areas for behavior change. The CRC also just completed a survey of 400-600 Oregonians about their receptivity to making behavior changes that will positively impact water. The initial focus of their messaging strategy will focus on reducing use of fertilizers and pesticides and promoting waterwise gardening to reduce pollution in stormwater*

1:05 South Umpqua Pilot Study

*The South Umpqua Pilot Study is currently on hold. During exploratory monitoring, at no time was a pesticide detected above 15% of an Aquatic life benchmark. Atrazine has however been detected at a frequency approaching 60% which would make it a pesticide of moderate concern. Other areas of the state with potential pesticide and water quality concerns and intensive ag & urban land uses have approached the program about launching a PSP. Given these developments, the WQPMT will discuss and if possible make a decision to continue or not to continue our efforts in the South Umpqua.*
