

# Shellfish Plat Pre-Application Questionnaire

This questionnaire is a compilation of questions provided by Oregon Department of Agriculture (ODA), Oregon Department of Fish and Wildlife (ODFW) and Oregon Department of Land Conservation and Development (DLCD). Before applying for a shellfish plat these three agencies will meet with you, for the purpose of reviewing your plans and increasing your chances of having your plat approved. Some plats are denied at the end of a long process and after the applicant has paid the non-refundable application fee of \$250. Our goal is to decrease the number of plats that are denied by having this meeting before you apply and pay the fee. However, this meeting is not a guarantee your application will be approved. Part of the application process includes the public comment period, in which other state agencies, local governments and land use authorities, tribes, local businesses, other shellfish companies, conservation groups, and others, provide opinions on if your plat should be approved. These comments can cause an application meeting hopes to address as many of these issues as possible. By the end of the meeting you should know whether or not your plat is acceptable to ODFW and DLCD, or if there are problems. We may be able to help you pick a location with a better chance of making it through the application process and being approved.

# **INSTRUCTIONS**

ODA has provided you with this questionnaire, a map of the growing area and a flowchart. Mark the map with the approximate location of the shellfish plat, be sure the corners are clearly marked. Fill out this questionnaire as completely as possible, and return the map and questionnaire answers to ODA. Once ODA receives them, ODA will schedule the pre-application meeting. After the meeting ODA will provide a plat application if a suitable plat location has been found.
