#### Background

The Oregon Department of Forestry (ODF) is considering a potential Habitat Conservation Plan (HCP) and associated Incidental Take Permit for state forestlands west of the Cascade Range. ODF is also seeking stakeholder engagement in this early phase of HCP consideration.
