

# Contracted Class C Testing Businesses

Class C testing businesses offer DMV drive tests for first-time driver license applicants, and others who require testing and are otherwise eligible for a driver license.

Some individuals, such as people who are in the at-risk program and others who require specialized testing, may be ineligible to take a test with a third party. You can find out if you're eligible by contacting DMV or a third party testing business.
