Subject: Ramp Closure: I-105/OR126 Ramp Closures (Eugene)

Effective April 11, 2024, the following ramps will be closed Sunday through Thursday nights from 7:00 p.m. to 5:30 a.m. These restrictions are necessary for bridge deck repairs. The estimated completion date for this work is May 13, 2024.

- I-5 southbound Exit 194A off-ramp to I-105/OR126 eastbound
- I-105/OR126 westbound Exit 4A off-ramp to I-5 southbound
- I-5 northbound Exit 194B off-ramp to I-105/OR126 westbound
- I-5 southbound Exit 194B off-ramp to I-105/OR126 westbound



### **Detour Route Information**

When I-5 southbound Exit 194A off-ramp to I-105/OR126 eastbound is closed, motor carriers can use

Exit 191 to Glenwood Boulevard, enter I-5 northbound, take Exit 194A to I-105/OR126 eastbound. When I-105/OR126 westbound Exit 4A off-ramp to I-5 southbound is closed, motor carriers can take Exit 2 to Coburg Road, to go eastbound on I-105/OR126, take Exit 4A to I-5 southbound. (Max vertical Clearence is 15'3" in the left land and 14'08" in the right lane). When I-5 northbound & southbound Exit 194B off-ramp to I-105/OR126 westbound, is closed, motor carriers can use Exit 194A to I-105/OR126 eastbound to Pioneer Parkway to W. "Q" Street to I-105/OR126 westbound.

Motor Carriers need to provide this information to their drivers, by copy of this letter or other means, to assure their awareness of the restriction.
