1. Title VI History and Context

The Civil Rights Act of 1964



"[n]o person in the United States shall, on the ground of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal assistance."



The Civil Rights Act of 1964

- Foundational and sweeping Civil Rights law passed in 1964 includes 10 titles.
- Other protections you may know:
 - Voting Rights (Title I)
 - Desegregation of Public Education (Title IV)
 - Equal Employment Opportunity (Title VII)
- Federal law and the primary enforcement mechanism is through condition of federal funds.



Principles Under Title VI

- Promote full and fair participation in public transportation decision-making without regard to race, color, or national origin.
- Ensure the level and quality of public transportation service is provided in a nondiscriminatory manner.
- Ensure meaningful access to transit-related programs and activities by persons with limited
 English proficiency through language assistance measures.



2. Title VI Requirements

Title VI Requirements

- FTA requires all recipients to document their compliance by submitting a Title VI Program to their Regional Office once every three years.
- ODOT's Title VI compliance includes our monitoring and oversight of our subrecipients.
- Plans need to be reviewed, updated, and approved by your governing body on a 3-year basis.
- Some additional Title VI Program elements are applicable based on the type of transit service or other federal funding sources.



Title VI Requirements

- When a Title VI Program is reviewed by ODOT, FTA, or a contractor we are looking for the same fundamental elements.
- Recommended resource for Oregon transit providers is the ODOT Title VI Handbook.
- Other resources include:
 - FTA Contractors Manual
 - Title VI Circular 4702.1B



Title VI Requirements

- A Federal-aid recipient must have a formal plan to prevent discrimination in all of its programs and activities.
- Title VI Programs are used to ensure compliance with Title VI of the Civil Rights Act of 1964, and to give transit employees, members of the general public, ODOT and the FTA a consistent and easy "roadmap" of the transit provider's Title VI compliance.
- Pass-through entities are not exempt from Title VI, however Title VI Program elements may be developed in a conjunction with pass-through and provider.



Reporting Schedule



Every 3 Years Complete Title VI Plan Update

Annually

- Title VI Program Changes
- Complaints and Lawsuits
- Outreach Activities



Title VI Plan - Required Elements

Every Title VI plan must contain the following:

Notice of Rights Under Title VI

How to File a Complaint

Title VI Complaint Form

List of investigations, complaints or lawsuits

Public Participation Plan

Limited English Proficiency (LEP) Plan

Minority Representation Table

Approval from Governing Body



Notice To the Public

Title VI Notice must include:

- A statement that the agency operates programs without regard to race, color or national origin
- Information on how to request additional information about the agency's Title VI obligations, such as how to file a complaint or how to request language assistance
- Title VI Plan reviewers look for where Notice is posted
- If you have LEP requirements, the notice should be posted available in other languages



Title VI Complaint Form & Procedure

Title VI Complaint Procedure should include:

- How to file the complaint (including timelines and access to a complaint form)
- How the agency will respond to the complaint (including timelines)
- How to appeal the agency response
- Include timelines and complaint form

ODOT has guidelines and examples available



List of Complaints & Lawsuits

- The agency's Title VI Plan should include an example of the complaint log, but not include details of specific complaints.
- Complaints can also be filed with ODOT or FTA
- If you have a complaint filed, ODOT of FTA can assist and provide guidance on resolution.



Limited English Proficiency (LEP) Plan

Safe Harbor

Safe Harbor requires, at a minimum:

written translation of vital documents for each LEP group that meets the LEP language threshold of <u>5%</u> or <u>1,000</u> individuals (whichever is less).



Minority Representation on Boards

- The subrecipient must provide the demographic membership of any transit-related, non-elected boards, advisory councils, or oversight committees
- Include description of outreach efforts to recruit representation of underrepresented community members



Other Potential Requirements

If you provide Fixed Route Services, you must include:

- Fixed Route Service Standards
- Fixed Route Service Policies

If you plan to construct new facilities, you may be required to conduct an Equity Analysis.



Governing Body Resolution or Approval

- Your agency approves its own plan (not ODOT or FTA)
- Board of Directors Resolution
- Meeting Minutes
