

VETERANS' HOME LOAN ELIGIBILITY

Important Submission Instructions

The VETERANS' HOME LOAN ELIGIBILITY form is used to aid in establishing eligibility for the ORVET Home Loan Program. Please include this completed Oregon Department of Veterans' Affairs (ODVA) form with:

- copies of your military separation/discharge document(s) showing Honorable or General Under Honorable Conditions discharge for each and all periods of active duty service (if other than a DD Form 214, please contact ODVA before submission at (503) 373-2051);
- if your name has changed since your military service, you must submit substantiating evidence of all such changes (for example, copies of marriage certificate, divorce decree, court order, etc.).

Send the documentation to ORVET Loan Eligibility, via secured email at **ODVA_OrVetsHomeLoans@odva.oregon.gov**. As an alternative, you may mail the documents to ORVET Loan Eligibility, 700 Summer Street Northeast, Salem, OR 97301-1285; or fax the required documentation to ORVET Loan Eligibility at (503) 373-2393. **NOTE:** Please do NOT send documentation to any other ODVA email address or via unsecured email.
