  - i) Sarah Puls is working on the State of the State Capability Assessment and will share with this group moving forward.
  - ii) On the ODEM Website there is now a preparedness calendar that identifies a host of opportunities including training.
  - iii) Save-the-Date for Oregon Prepared has been sent out, its OEM annual conference focusing on preparedness activities for out local and tribal partners.
