### Mobile Health Pilot Program Update

OHA is currently drafting Grant Agreements in collaboration with Grant Recipients and the Contracts Office. Each Grant Agreement receives review by the Department of Justice for legal sufficiency. Upon successful completion of Grant Agreements, funds will be awarded, in full, to each Grant Recipient.

### Program Spotlight

OHA has selected the following Grant Recipients for award to implement the Mobile Health Unit Pilot Program:

- **Central City Concern** proposes to launch a Mobile Medical Pilot Project (MMPP) in coordination with Medical Teams International (MTI) and Portland Street Medicine (PSM) with the aim of improving access to primary health care—including wound care, infectious disease screening and treatment, vaccinations, medication prescriptions and more—for people experiencing homelessness in the Portland metro area.
- **The Confederated Tribes of Grand Ronde** is a confederation of over 27 tribes and bands from western Oregon to northern California and is comprised of 5,400 enrolled Tribal members. The Tribe is among Oregon’s nine federally recognized tribes. In addressing the Tribe’s overall goal in reducing the incidence of opioid use disorder among Tribal, other AI/AN, and community members within a medically underserved area, the Tribe intends to purchase and assemble a mobile mediation-assisted treatment unit to reduce systematic and physical barriers for treatment and provide culturally relevant and inclusive care.
- **Raíces De Bienestar’s** ‘Mobile Mental Health’ pilot program is dedicated to bringing mental health and wellness treatment to un- and under-insured Latine/x Oregonians. The Raíces model of Mobile Mental Health is meant to be highly collaborative and integrative with other community agencies in the geographies we serve as well as the clients themselves. Mobile Mental Health will circumvent the challenges and barriers of serving the Latine/x community by ensuring all our programming speaks to them and their needs—such as a focus on family, conversation, and working together as a community.

### HB 4052 Legislation and Funding

HB 2918 and HB 2925 both await funding decisions from the legislative body. Funding is awarded to bills by the Joint Committee on Ways and Means. A Work Session has been scheduled for HB 2925. No meeting dates have been scheduled for HB 2918.

HB 2925 has been assigned to the General Government subcommittee within the Joint Ways and Means Committee, while HB 2918 awaits subcommittee assignment.

- **HB 2925: Extends the timeline needs to accomplish the Legislative Reporting requirements of HB 4052.**
- **HB 2918: Provides the necessary \$4million in funds for the Mobile Health Pilot Program.**
