**Subject:** ASAM Foundational Trainings

The Oregon Health Authority, Behavioral Health Division will be offering the following ASAM Criteria® trainings based upon availability through June 30, 2025 to support the Oregon Substance Use Disorder Provider Network\*:

### **ASAM Criteria Online Foundations Course (Edition 3 or 4\*\*)**

This online course is designed to help counselors, social workers, administrators, payers, and other clinical staff develop patient-centered service plans and make objective decisions about patient admission, continuing care, and transfer/discharge for individuals with addictive, substance-related, and co-occurring conditions. The content is based on information found in The ASAM Criteria®: Treatment Criteria for Addictive, Substance-Related, and Co-Occurring Conditions, **Third or Fourth\*\*** Edition.

**Registration Process:** Individuals needing to take the course need to email [ASAM.Training@odhsoha.oregon.gov](mailto:ASAM.Training@odhsoha.oregon.gov) requesting access to the training. Please utilize **ASAM Training Criteria Access** in the subject line of the email. Please indicate the following information: county, agency, name of participant, email of participant, and credentials of individual. It is acceptable to submit one email with the attached excel spreadsheet with the information of staff requesting the ASAM Criteria Online Foundations Course. Directions will then be provided for the learner on how to set up an account within ASAM eLearning Center (eLC) if they have not already done so. In addition to the directions, we will also include the promotional code needed to access the OHA sponsored training - ASAM Criteria Online Foundations Course. Accounts within the eLC are specific to the individual, and it is important that each learner has their own account to be able to access the training. The trainings cannot be shared across learners.

\*Current Oregon Administrative Rule requires Oregon Substance Use Disorder Providers to complete an ASAM Criteria training once every two years and, at this time, list ASAM Criteria Edition 3. The Oregon Health Authority anticipates updated OAR will require training to ASAM Criteria Edition 4 beginning July 2025.

**\*\*PLEASE NOTE: promo codes will be provided based on chosen training edition and will allow you access to ONE training. Access to both edition 3 and edition 4 trainings is NOT being provided at this time. Please verify the appropriate edition with your agency director/manager prior to registration.**
