

Moda Health Plan, Inc. (Moda) currently meets the requirements of an organization that has a certificate of authority in good standing as a health care service contractor and issues health benefit plans as defined in 743B.005, in Oregon. Moda's subsidiary company ODS Community Health, Inc. is an equity partner and administrator of the Eastern Oregon CCO that has held a Medicaid contract with OHA to bear capitated health care financial risk since 2012.

Our intent in forming the West Central CCO is to bring on additional equity partners such as local hospitals and other provider partners that currently provide care and services to OHP members in the desired service areas. Moda intends to reduce its equity/ownership position in the new company based on the equity/ownership taken by our hospital and provider partners.




EXHIBIT A: Organization chart






EXHIBIT B: Oregon Health Care Business
