Komaroñ bar kajeoñ dreloñ ippān Medicare online ilo [ssa.gov/medicare/sign-up](https://ssa.gov/medicare/sign-up). Ak komaroñ etal ñan [OregonHealthcare.gov/GetHelp](https://OregonHealthcare.gov/GetHelp) ñan am pukot juon ri-jerbal in injuren ak ri-jipañ ro ilo Senior Health Insurance Benefits Assistance Program eo. Rej maroñ jipañ lale ta ekkar ñan kwe ilo Medicare injuren eo.

**Ne kwojjab eligible ak jab maroñ dreloñ ilo Medicare, lale ñe ewor injuren in taktō jān jikin jerbal eo am im emman onean ñan ri-jerbal.** Kōnaan ippān boss eo am ak eo ej lale ri-jerbal ro ak human resources department eo an jikin jerbal eo mokta jen an jemlok OHP injuren eo am.
