

DISCLAIMER

The Oregon Liquor and Cannabis Commission (OLCC) has developed and implemented a Chance to Purchase Event (Event) to provide an opportunity for Oregon residents to purchase distilled spirits that manufacturers or suppliers release in limited quantities.

The Event will include a series of drawings for a variety of items.

An “item” is defined as a unique distilled spirit offering listed with the OLCC. There may be multiple bottle quantities available of each item for a drawing.

GENERAL: There is no cost to enter a drawing or obligation to purchase other merchandise at a liquor store to enter any drawing. Participants whose entry is drawn may decline to purchase the winning item. Winners are not required to purchase any other distilled spirit item or non-distilled spirit merchandise if they choose to purchase the winning item. Purchases of distilled spirits will not increase chances of winning.

Participation in a quarterly Event is limited to one entry per person, and the participant may choose up to five different items from the list of items offered. Each item will have its own drawing.

The person who enters and wins must be the same person who purchases the item for personal use or a gift. **This item cannot be resold or purchased on anyone else’s behalf.** If a winner is on active military duty stationed outside of Oregon, they may contact OLCC at olcc.chancetopurchase@oregon.gov for options to purchase their bottle.

Entry information submitted may be shared within OLCC and with liquor stores for tracking, shipping, and selling purposes. Part or all of a person’s name may be used in promotional material or a public records request. Otherwise, entry information will be considered confidential.

PURCHASE PRICE: The purchase price stated for each item is the price set at the time the drawing is offered. The purchase price may change depending on factors used in OLCC’s pricing criteria and pricing formula for all distilled spirits. OLCC reserves the right to change or correct pricing errors at any time.

ELIGIBILITY TO PARTICIPATE: To be eligible to participate in any Event, a participant must be an Oregon resident who is at least 21 years of age. This includes active-duty military who are residents of Oregon, but are duty stationed outside of Oregon.

A valid, unexpired Oregon Driver License or Oregon Identification Card issued by the Oregon Department of Motor Vehicles is required at the time of purchase and must match the information entered on the entry form.

Employees of the OLCC, a Retail Sales Agent or an individual representing a Retail Sales Agent that is a legal entity (Agent Representative) are not eligible to participate. OLCC may disqualify any person from participating in this or future Events for failure to meet these qualifications or for any other conduct deemed to be inconsistent with the state alcohol laws and regulations or the requirements of this Event. OLCC is not

obligated to sell the winner an item if the person would not ordinarily be allowed to purchase under Oregon's laws, if the bottle becomes unavailable, or if OLCC is precluded by other laws or legislative actions that prohibit it from selling the item.

LIMIT ON NUMBER OF ENTRIES: Participation in quarterly Events is limited to one entry per person. The participant may choose up to five different items from the list of items offered.

Any participant who submits multiple entries or is suspected of submitting multiple entries under different identities will be disqualified from entering this Event or the next Event.

DRAWING PROCESS: A random drawing will be utilized to select the winning entries for each listed item. Each entry will be reviewed prior to the drawing to confirm the eligibility of the participant and the entry. The OLCC reserves the right to make determinations as to ineligible or disqualified entries.

The most expensive retail priced item will be the first item to be drawn. Then each subsequent item by decreasing price point will be drawn until all items are exhausted.

Once a winner has been chosen for the opportunity to purchase an item, any remaining entries by that person for other items are null and void.

WINNING ENTRIES AND NOTIFICATION OF WINNERS: The OLCC will notify winners by email that their entry was selected as a winner. A Chance to Purchase item will be shipped to the liquor store specified on the entry form and the liquor store will notify winners by phone when the product arrives. A winner must purchase the winning item within 14 calendar days of notification from the liquor store and the item must be paid for in full at the time of purchase. The winner's name and Oregon Driver License number or Oregon Identification Card number entered on the entry form must match the identification presented at the time of purchase at the liquor store. If the winner fails to purchase the winning item within this time limit, the winner will be deemed to waive their right to the winning item. Winning items that remain unclaimed for more than 14 days will be made available for sale.

PROHIBITED CONDUCT/SOLICIT OR RE SALE OF PRODUCT/CRIMINAL ACTIVITY PROHIBITED: OREGON REVISED STATUTE 471.405 STATES IT IS AGAINST THE LAW TO SOLICIT OR RESELL ALCOHOLIC BEVERAGES BY ANY PERSON NOT AUTHORIZED BY OLCC OR OREGON LAW, TO DO SO IS A CRIME.

ANYONE SUSPECTED OF ENGAGING IN FRAUDULENT OR OTHER CRIMINAL ACTIVITY IN CONNECTION WITH A DRAWING OR OTHERWISE WILL BE REPORTED TO THE APPROPRIATE LAW ENFORCEMENT AUTHORITIES AND WILL BE PROHIBITED TO ENTER FUTURE EVENTS.
