Marijuana Security Waiver Request

What is this form?

[OAR 845-025-1400\(1\)\(a\)](#) allows a recreational marijuana licensee to request that the Commission waive one or more of the security requirements described in [OAR 845-025-1400 to 845-025-1470](#) by submitting a security plan for approval. Applicants or Licensees may use this form to document the required information in order to make such a request.

What must be included?

- The specific rule and subsections of a rule that is requested to be waived;
- The reason for the waiver;
- A description of the intended alternative safeguard and how it accomplishes the goals of the rules specifically as relates to:
 - Public safety;
 - Preventing diversion of product;
 - Licensee accountability;
 - Preventing minors from gaining access to the premises and marijuana items.
