Pursuant to a duly adopted delegation order, and acting in accordance therewith, the Director, or her designee, has approved the following actions on behalf of the Oregon Parks & Recreation Commission:

SCENIC WATERWAYS NOTIFICATION

On November 7, 2022, Notification of Intent NOI 07-742-22 was approved to allow the property owner to repair a septic system at 268 Pickett Creek Road, Grants Pass, in the River Community Area of the Lower Rogue State Scenic Waterway. The completed project does not impact the scenic values of the river in this section.

November 18, 2022, Notification of Intent 2B-1103-22 was approved to allow for the remodel of an existing single-family residence in the Upper Deschutes Scenic Waterway at 58069 Siskin Lane, Sunriver. The construction was approved because it is outside of 100' setback, well below height limit, finished in materials and colors that blend in with surrounding environment, and maintains existing vegetation screening on site.

On December 5, 2022, Notification of Intent 2B-1104-22 was approved to allow the construction of a new single-family dwelling in the Upper Deschutes Scenic Waterway at 16184 Mountain Goat Lane, La Pine. The project was approved because it complies with all relevant Upper Deschutes River Community Area Scenic Waterway rules and does not impede the scenic values of the river in this section.

On December 22, 2022, Notification of Intent NOI 07-733-22 was approved to allow the property owner to install temporary structures lost to the 2021 wildfires at the Galice Resort, 11744 Galice Road, Merlin, in the River Community Area of the Lower Rogue State Scenic Waterway. Replacement of structures lost due to natural disasters is permissible under the State Scenic Waterway rules, provided the structure is in the same footprint and meets the other requirements as described in rule.

On January 5, 2023, Notification of Intent 4-212-23 was approved for Fraizer Haney of the Wildlands Conservancy for construction of two new structures and a driveway on the John Day Scenic Waterway. The approval was given because the structures will be finished with stained wood, are below the height limitations, meet setback requirements, there is mature vegetation, and will plant new vegetation to screen the structures from the view of the river.

On January 31, 2023, Notification of Intent 2A-289-23 was approved to allow the construction of a new single-family dwelling in the Middle Deschutes Scenic Waterway at 20440 Swalley Road, Bend. The project was approved because it complies with all relevant Middle Deschutes River Scenic Waterway Scenic River Area rules, will be constructed to blend in with the natural landscape, and does not impede the scenic values of the river in this section.

OCEAN SHORES ALTERATION DECISIONS

On October 28, 2022 permits 3017-22 was issued to construct 100 feet of riprap revetment along the ocean shore adjacent to 26 Ocean Wind Lane in the Salishan development. The revetment replaces a structure built in 1973 and work performed in 2021 under an emergency permit.

On October 28, 2022 two permits (3018-22 and 3019-22) were issued to construct 182 feet of riprap revetment along the ocean shore adjacent to 22 South Lagoon Lane in the Salishan development. The revetment replaces a structure built in the 1970s and work performed in 2021 under an emergency permit.

TIMBER HARVEST REVENUE

On January 5, 2023 OPRD received \$69,468.00 in timber revenue for 100% of the total timber volume salvaged from Ben and Kay Dorris State Park.
