## FLOATING PROPERTY INHERITANCE AFFIDAVIT

If the estate of the deceased owner(s) is <u>not or will not be probated and no personal</u>
representative or executor has or will be assigned, this form may be used and submitted with the following items.

- Original Certificate of Title for a Floating Property or Lost Boat Floating Property Title Application
- Copy of death certificate or obituary for each deceased owner

## Form Instructions:

- All heirs must be listed or if no heirs, list 'none'. If there is more than one heir, the heirs may either complete and sign the same affidavit or complete and sign separate affidavits. The signatures must be signed before a Notary Public. The Marine Board may not determine who the heirs are and you may need to seek legal counsel.
- If the heir is a minor or incapacitated, the parent or guardian must sign for the heir and supply documentation when applicable. Example: John Jones by Jim Jones, (Parent or Guardian)

Refer to ORS Chapter 112 (Intestate Succession and Wills) and 114 (Small Estates) for more information. For estates being probated or processed as a small estate, the Marine Board requires copies of the letters of testamentary or other court appointment of a personal representative or executor along with proof of death, a copy of the will, applicable fees and the original title or lost title form.
