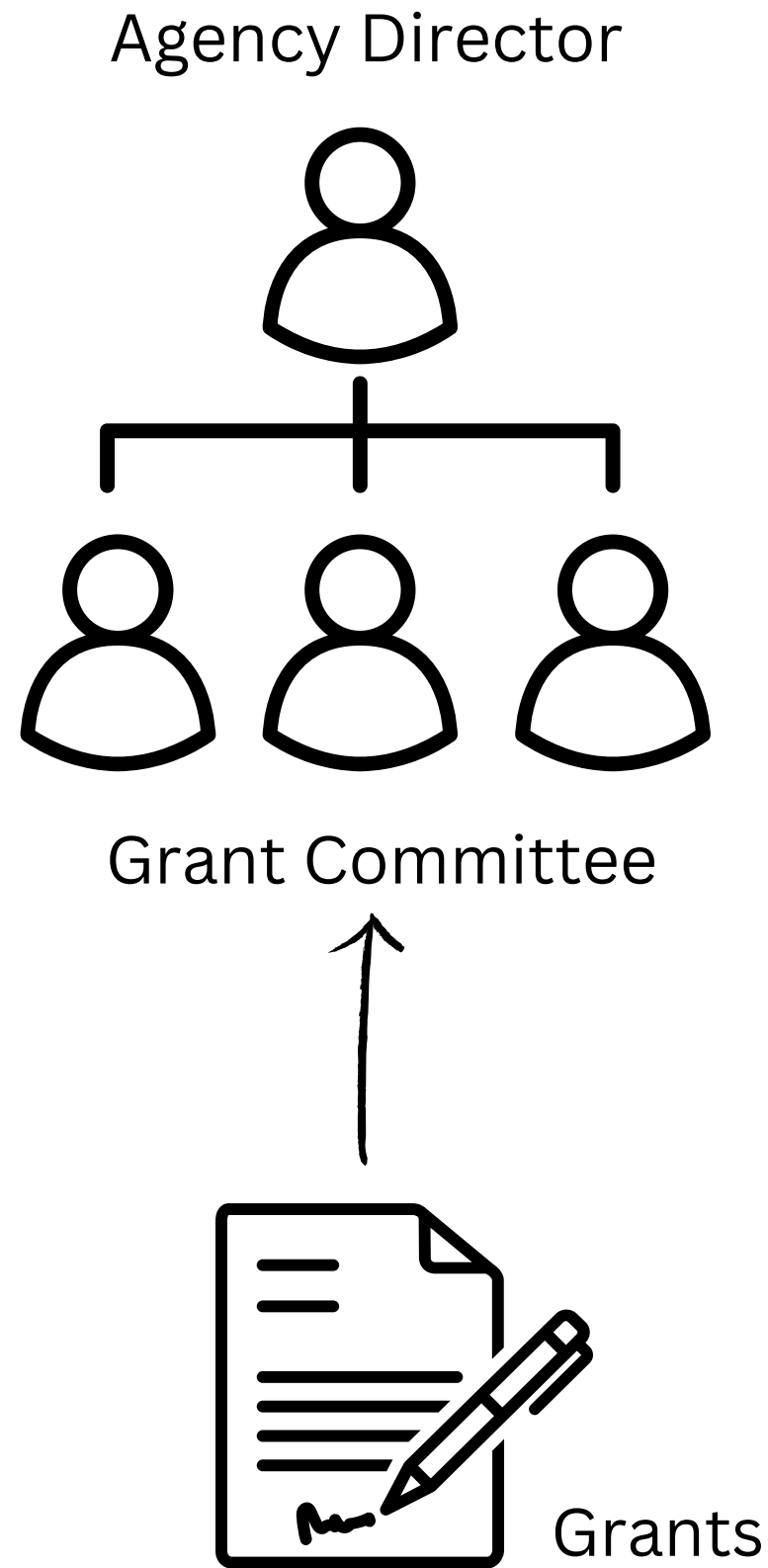

Total Grant Funds Issued (GF): \$1,332,106.19

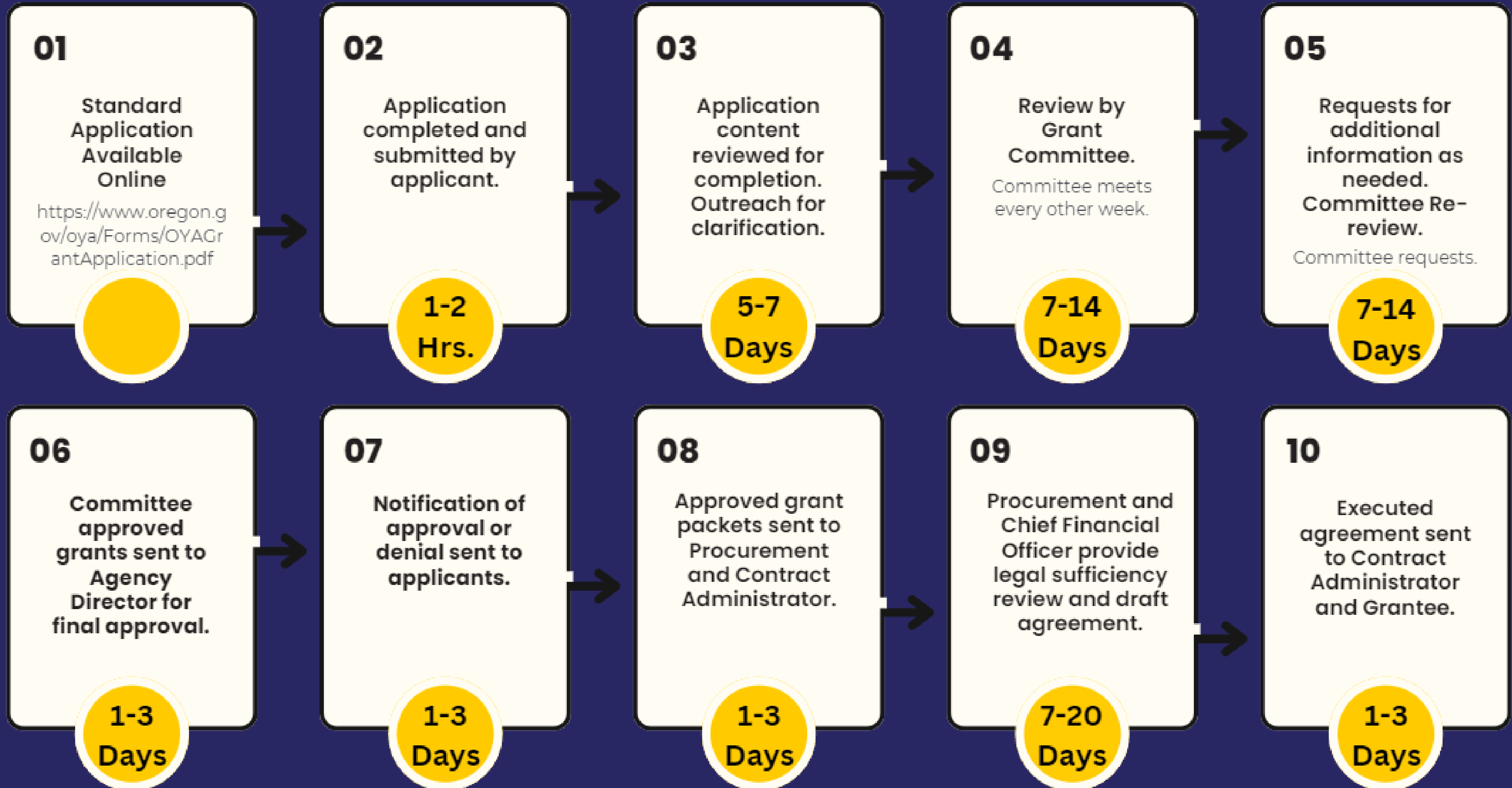
Specific Service - Grants

- OYA Financial Grants are available for local governments, nonprofit organizations, and individuals seeking to meet the treatment and care needs of OYA-adjudicated youth.
- start-up costs and capacity building for a new treatment or service delivery program
- culturally-responsive and/or trauma-informed programs/program efforts
- emergency health and safety needs
- ***Must have existing or contract in process for youth services***

Specific Service - Contracts

- Available to all organizations looking to do business with a state agency. (Follows State procurement process as applicable)
- Budgeted and Non-Budgeted Agency operational expenses
- Long-term, ongoing youth services

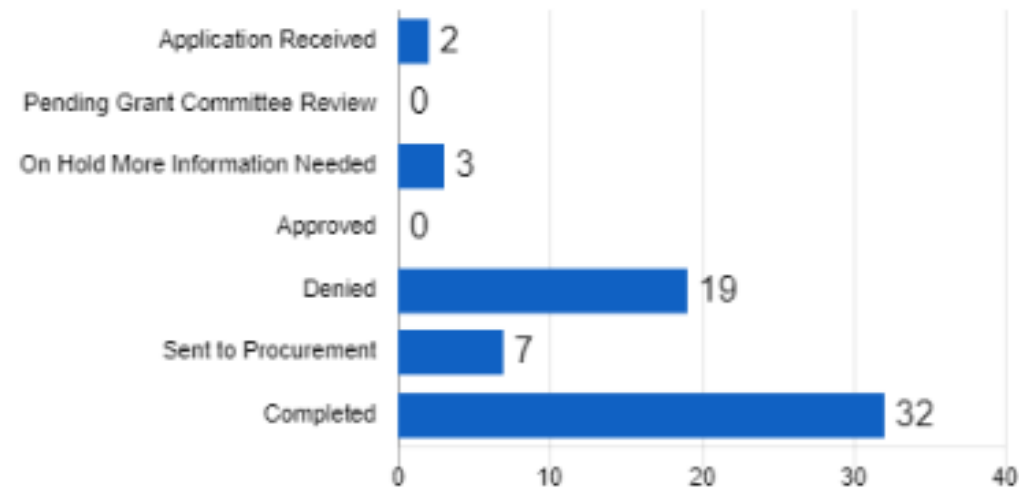

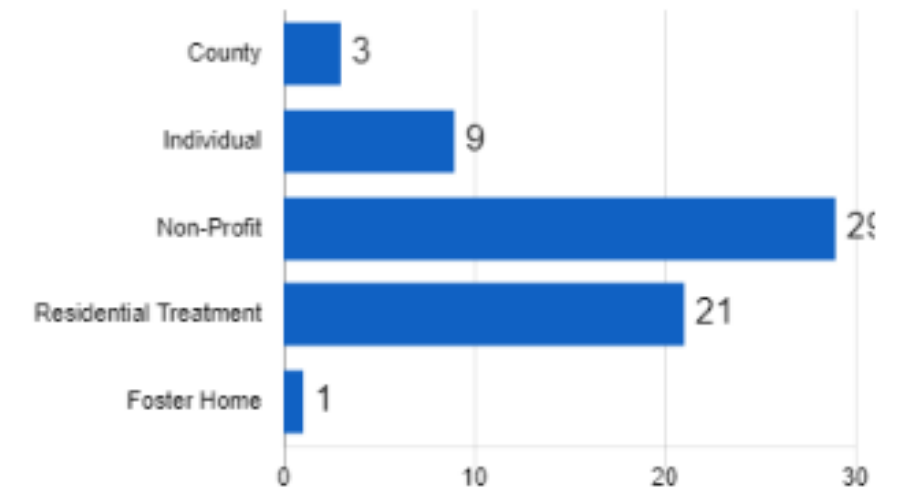

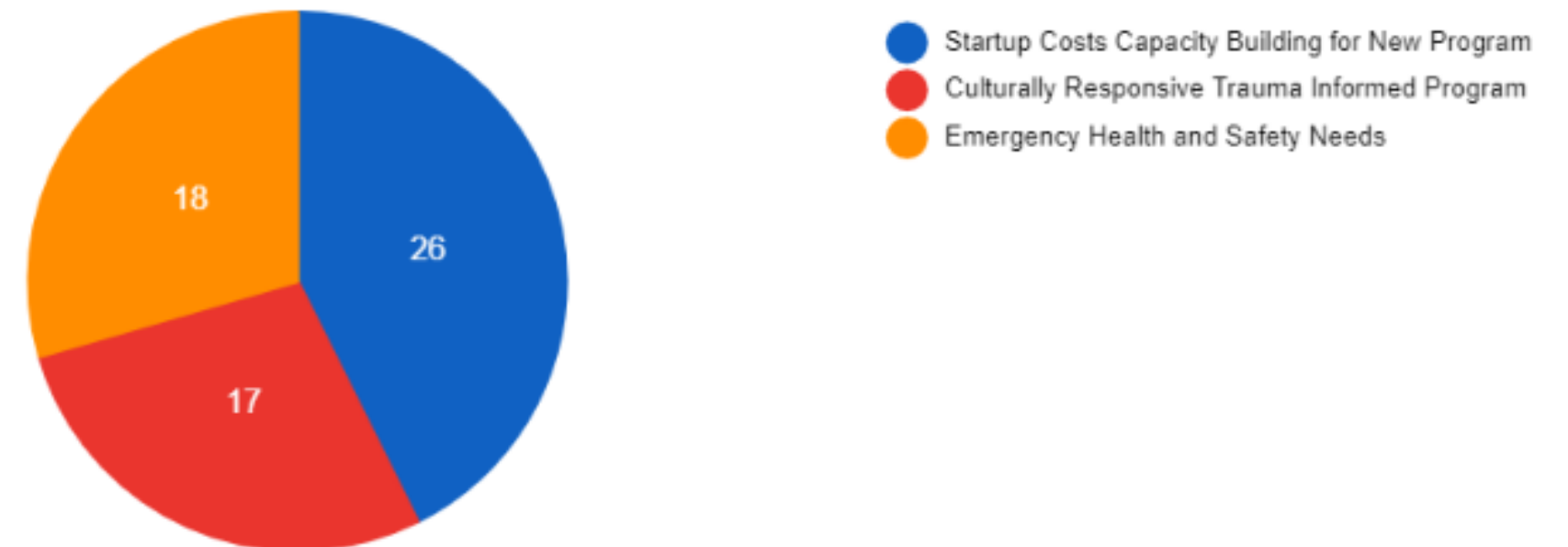
Status of Grant Applications

The payment method is determined by the Grant Committee based on the following factors:

- Service Category
- Situation
- Program Assessment
- Financial Risk Assessment

Funds not fully expended within the timeframe or expenditures outside of those listed in the grant agreement are recouped by the Agency.

The Agency has offered extensions and/or agreement amendments through the Grant Committee.



Admin/Indirect Policies

Our Agency does not currently have any policies specific to Admin/Indirect costs.

All grant funding must be applied to services for youth under our three allowable categories.
