## Introduction

Oregon's juvenile justice community is committed to providing effective and efficient services to promote public safety, ensure justice for victims, and prevent youth from repeating criminal behavior.

This document contains statewide and county specific reports describing youth admissions to and releases from juvenile detention facilities.

### Contents of this report

There are four tables within this report:

#### **Detention Admissions Overview**

The total count of unique admissions to a detention facility during the year by Admitting Agency (County or OYA/DOC) and the demographic characteristics (age, sex, and race/ethnicity) of the youth being admitted.

#### **Detention Releases Overview**

The total count of unique releases from a detention facility during the year by Admitting Agency (County or OYA/DOC) and the number of days the youth spent in the detention facility (length of stay).

#### **Detention Admissions by Demographics**

This table expands upon the Detention Admissions Overview table by providing a count of unique admissions by Admission Reason in addition to the Admitting Agency (County or OYA/DOC) and the demographic characteristics of the youth.

#### Detention Releases by Length of Stay\*

This table expands upon the Detention Releases Overview table by providing a count of unique releases by Admission Reason in addition to the Admitting Agency (County or OYA/DOC) and length of stay.

\*As of the 2023 reporting year, length of stay is no longer presented by youth demographics because length of stay is highly dependent on the admission reason (e.g., New Law Violation vs Probation Violation). Without additional context, length of stay by youth demographics could easily be misinterpreted.

#### Notes about the information

**Admitting Agency:** Admitting agency [County or Oregon Youth Authority/Department of Corrections (OYA/DOC)] is determined by the youth's most intense open disposition on the day they were admitted to detention.

**Admissions:** An Admission is an entry into a detention facility during the reporting year. It is possible for a youth to have more than one admission in the reporting year. Some county

juvenile detention facilities operate Detention Based Youth Care Centers within their detention facilities. Admissions to Detention Based Youth Care Centers are not included.

**Length of Stay:** Length of Stay is computed by subtracting the admission date from the release date. If a youth is admitted and released on the same day, the Length of Stay is one day. Length of Stay is only computed for youth who have been released from a detention facility. The Admission may have occurred in a prior reporting year.

**Reporting Year:** The calendar year is used for the reporting period.

**County:** This is a youth-based report, not a facility report. Starting with the 2023 reporting year, each admission is assigned to the county that was supervising the youth at the time of the detention admission. This is a change from prior reports, in which admissions were assigned to the county that had jurisdiction over the youth at the time the detention reports were produced.

**Demographics**: The JJIS Steering Committee recognizes that reporting race, ethnicity, sex, and gender in JJIS may not accurately represent everyone, due in part to a need to comply with federal reporting requirements. We respect all individuals, but also acknowledge and regret we cannot capture how individuals may self-identify in these areas.

- **Race and Ethnicity:** The JJIS Steering Committee defines Race/Ethnicity reporting categories based on available data. Race is recorded by the juvenile department based on police reports and youths' self-reporting. These reports categorize youth by the race that is recorded in JJIS unless the recorded ethnicity is Hispanic. When the recorded ethnicity is Hispanic, the youth is categorized as Hispanic, regardless of race.
- Sex: The options for reporting sex currently include Male, Female, or Unknown. There are current state and national discussions about new ways to document sex that are respectful and inclusive of all. The JJIS Steering Committee will continue to engage in those discussions and make updates in this area as available.

#### Cautions regarding detention data

**Comparing reports:** It is not possible to compare the admissions report to the releases report. The Admissions by Demographics report is based on youth admissions during the current reporting year; however, the Releases by Length of Stay report reflects releases of youth who may have been admitted in a prior reporting year.
