RULE SUMMARY: Permanently adopts a temporary rule from 5/5/2023 that allows Drug Outlet pharmacies to implement USP <795> Pharmaceutical Compounding Non-Sterile Preparations (v. 11/01/2022) and <797> Pharmaceutical Compounding – Sterile Preparations (v. 11/01/2022).

The United States Pharmacopeia (USP) published its revised standards for USP General Chapters <795> and <797> on November 1, 2022. These new USP standards will be effective on November 1, 2023. The board anticipates future rulemaking to adopt USP <795> (v. 11/01/2022) and <797> (v. 11/01/2022) by reference and repeal USP Chapters <795> (05/01/2020 v. 2014) and USP <797> (05/01/2020 v. 2008). Due to the numerous and complex process changes required for compliance, registrants may implement the revised USP <795> (v. 11/01/2022) and <797> (v. 11/01/2022).

CHANGES TO RULE:

855-045-0205

Compliance with New Standards

As an alternative to the requirements in OAR 855-045-0200(3)(a) and (3)(b) registrants may comply with any or all standards contained in:

(1) USP <795> Pharmaceutical Compounding-Non-Sterile Preparations (11/1/2022).

(2) USP <797> Pharmaceutical Compounding-Sterile Preparations (11/1/2022).
