& PHARMACY TECHNICIAN (PT) LICENSE
RENEWAL CONTINUING PHARMACY EDUCATION (CPE) FREQUENTLY ASKED QUESTIONS
New CPE rules – effective 7/1/2023 can be found in [OAR 855-135-0070](#)

1. I recently obtained my PT license in Oregon. Do I have to complete all 20 hours of CPE prior to renewing my license? It depends on your initial issue date on your license:

If you were initially licensed prior to July 1, 2023, in accordance with [OAR 855-135-0070](#), you MUST complete **20 hours of CPE** in the period of July 1, 2022 – June 30, 2024.

Per [OAR 855-135-0070\(1\)](#), to be eligible for renewal, you must complete the following:

- (a) Two hours of CPE in pharmacy law;
- (b) Two hours of CPE in patient safety or medication error prevention;
- (c) Two hours of CPE in cultural competency either approved by the [Oregon Health Authority under ORS 413.450](#) or any cultural competency
- (d) Fourteen additional hours of CPE in subjects pertinent to pharmacy per [OAR 855-135-0010\(1\)\(a\)-\(e\)](#).

If you were initially licensed in the period of July 1, 2023 – June 30, 2024, in accordance with [OAR 855-135-0070](#), you MUST only **complete 2 hours of CPE** in cultural competency for this license renewal.

Per [OAR 855-135-0070\(2\)](#), to be eligible for renewal you must complete:

- (1)(c) Two hours of CPE in cultural competency either approved by the [Oregon Health Authority under ORS 413.450](#) or any cultural competency

2. I recently obtained my CPT license in Oregon. Do I have to complete all 20 hours of CPE prior to renewing my license? It depends on your initial issue date on your license:

If you were initially licensed prior to July 1, 2023, in accordance with [OAR 855-135-0070](#), you MUST complete **20 hours of CPE** in the period of July 1, 2022 – June 30, 2024.

- (c) Two hours of CPE in cultural competency either approved by the [Oregon Health Authority under ORS 413.450](#) or any cultural competency
- (d) Fourteen additional hours of CPE in subjects pertinent to pharmacy per [OAR 855-135-0010\(1\)\(a\)-\(e\)](#).

If you were initially licensed in the period of July 1, 2023 – June 30, 2024, in accordance with [OAR 855-135-0070](#), you MUST only **complete 2 hours of CPE** in cultural competency for this license renewal.

Per [OAR 855-135-0070\(2\)](#), to be eligible for renewal you must complete:

(1)(c) Two hours of CPE in cultural competency either approved by the [Oregon Health Authority under ORS 413.450](#) or any cultural competency

3. How can I find CPE that counts as cultural competency (CCCE)?

[OAR 855-135-0001\(7\)](#) defines cultural competence.

ACPE offers a CPE search tool via the [Pharmacy Learning Assistance Network](#). You can utilize this nationwide database to locate ACPE approved CPE on a specific topic. Under the specific CPE interest, you can select topics like Bias, Cultural Competency, Cultural Diversity, Gender Identity, Health Disparities, Health Literacy, Health Inequities, LGBTQ, Social Determinates of Health, Transgender.

OHA maintains a list of [CCCE approved trainings](#) that meet the requirements of ORS 413.450.

4. Must my CPE be accredited by ACPE?

No, per [OAR 855-135-0001](#), accepted CPE includes any program that is ACPE accredited, board-approved or ACCME AMA Category 1. ACCME AMA Category 1 CPE is limited to 6 hours of CPE per renewal cycle.

5. Is use of the NABP CPE Monitor to track ACPE accredited CPE required?

Yes, per [OAR 855-135-0070\(3\)](#) which became effective on 7/1/2023, Certified Oregon Pharmacy Technicians and Pharmacy Technicians must register with the CPE Monitor for tracking completed ACPE credit hours.

To log in to your current NABP e-Profile account to verify your e-Profile number and ensure you have completed all CPE requirements prior to renewing your license, go to: <https://dashboard.nabp.pharmacy/#/login>.

6. During the renewal cycle, do I have to submit copies of my completed CPE to the Oregon Board of Pharmacy?

Please see [OAR 855-135-0070\(5\)](#). For each board-approved or ACCME accredited program, you must ensure that program completion CPE credit was recorded in either [NABP CPE Monitor](#) or that your certificates of completion have been uploaded to your eGov licensing record.

CPE Certificates may be uploaded on the "Attach Documents" page of the eGov renewal or may be uploaded at any time by logging into your [eGov](#) account and selecting "Update License Info and Upload Documents".

7. Does my CPE have to be “live” or “technician specific” to count for my Oregon license?

No.

8. New rules relating to technicians, interns and pharmacists went into effect on 3/1/2024. Does the Board have informational programs about the rule changes?

Important Note:

While these informational programs are Oregon board-approved, they are not accredited by ACPE. Therefore, completion of these programs will not appear in the NABP CPE Monitor. You must upload the course completion certificate for this program into your [e-Gov](#) licensing record to comply with CPE record retention requirements in OAR 855-135. Certificates will be emailed to those who complete the quiz and program evaluation 6-8 weeks after submitting the request.

9. I have been selected for audit but cannot find copies of my completed CPE. What should I do?

Please contact the CPE provider for proof of completion, as they are required to keep completed CPE on file for at least six years.

10. How long should I retain the proof of my CPE?

Per [OAR 855-135-0070\(6\)](#), you are required to retain proof of CPE for a minimum of six years.

11. I renewed my license and attested to the fact that my CPE will be completed by 6/30/2024, but I did not have all my CPE hours, or I cannot provide proof of completion. What happens next?

If you are audited and you did not complete or cannot provide proof of the required continuing pharmacy education prior to 6/30/2024, **a case will be assigned, investigated, presented to the board for deliberation and may result in disciplinary action.**
